Facilities

Facilities Update

Mr. Johnson updated the Board on the following facilities information: Working at NFES to get chimney added to BARD units on the back of the building to block the wind so they will not shut down during those conditions; Mason and Berry will be back on March 3 at PCMHS to get heat working in the auditorium; DSO is still here working on piping and duct work at night to get as much done as possible before they pull out. They will return on June 7 to get the work completed before school resumes; Waiting on bids for painting and other needs projects to get them prioritized; Looking at a security grant for lighting and door systems for NFES, Bus Garage and Board office; Grant to be pursued to get older doors at PCMHS replaced; new bus has been ordered and will be here in May.

Old Business There was none to discuss.

New Business There was none to discuss.

Other:

School Improvement/Student Achievement Update

Mr. Heavner updated the Board on the following school improvement/student achievement: T Mobile hot spots have been delivered to Janice Heavner at PCMHS to get them distributed to students who were identified earlier. Students who have received them are experiencing success with this new technology. The only issue is that the T Mobile map was not quite accurate indicating locations where they would work. Preschool registration online has been completed. At last check there were around 40 preschool registrations completed. Follow up will now begin to get all needed paperwork submitted. Summer school survey has been recirculated and several responses have been received. State department is now having a weekly webinar to prepare counties for Summer school offerings. Funding will be provided by the state for the program.

Superintendent's Update

Mr. Hedrick updated the Board on the following items: Basketball spectator guidelines include parents, grandparents and household members, but will be revisited later if room is adequate to add additional spectators. State funding for county summer school has been approved. Grant was offered for additional CSI grant funds and additional support projects and application was submitted. It has been approved in the amount of \$154,000. Updated school calendar for 2021 will change last day for students to June 4 and last day for staff to June 7.

Conference/Meeting Update

Mr. Hedrick and Ms. Hevener will be in Fairmont on March 12 for WVASA training on legal updates provided by Attorney Jason Long.
